

1. GENERAL

1.1 DESCRIPTION

1.2 HOURS OF WORK

- .1 The Contractor is hereby notified that the hours of work for this Contract are between the hours of 7:00 AM and 7:00 PM on weekdays and Saturdays, and between 9:00 AM and 7:00 PM on Sundays. These hours of work may be relaxed if, in the opinion of the Engineer, such relaxation is necessary to either expedite the Work, or reduce the impact of the Work on affected residents.

2. CONTRACT SPECIAL PROVISIONS
