A BYLAW OF THE CITY OF LLOYDMINSTER IN THE PROVINCES OF ALBERTA AND SASKATCHEWAN FOR THE PURPOSE OF CLOSING TO PUBLIC TRAVEL AND CREATING TITLE TO AND DISPOSING OF A PORTION OF PUBLIC ROADWAY IN ACCORDANCE WITH PART 2 DIVISION 2 OF THE LLOYDMINSTER CHARTER.

WHEREAS the Council of the City of Lloydminster deems it necessary to establish a Bylaw to deal with roads, including temporary and permanent openings and closings.

AND WHEREAS *The Lloydminster Charter* provides authority to City Council to pass bylaws for municipal purposes;

AND WHEREAS the lands hereafter described as are no longer required for public travel;

AND WHEREAS application has been made to Council to have a portion of the Lane closed;

WHEREAS the Council for the City of Lloydminster deems it beneficial to provide for bylaws for the purpose of closing certain roads to public travel, or portions thereof, situated in the said municipality, and thereafter disposing of same;

WHEREAS notice of the intention of Council to pass a Bylaw has been given with accordance with Section 159 of *The Lloydminster Charter*;

WHEREAS Council was not petitioned for an opportunity to be heard by any person deeming to be prejudicially affected by the Bylaw;

NOW THEREFORE, be it resolved that the Council for the City of Lloydminster, in the Province of Saskatchewan does hereby close to public travel and disposing of the following described roadway, subject to the rights of access granted by other legislation:

NW 02 50 28 3 Plan BA3882 Ext 1 As described on Certificate of Title QK136.

EXCEPTING THEREOUT ALL MINES AND MINERALS

The portion to be closed is shown on the map, attached as Schedule "A" which forms part of this Bylaw.

This Bylaw shall come into force and effect upon the final passing thereof.
