HOME-BASED BUSINESS APPLICATION & LICENCE PROCESS





Licence Renewal Schedule

Home-based business licences are renewed on an annual basis.

After receiving the renewal letter, businesses are required to submit payment, in-person, online or over the phone to avoid late payment penalties.

When does my home-based business need a development permit?

If you are planning on operating a new business where the scope involves more than doing paperwork out of your home or your are adding an additional business then a permit may be required.

Why does my home-based business need a permit?

The City is divided into districts. Within each district is a list of allowed uses, some are permitted and some are discretionary. This process will confirm if the use is allowed. Once approved you are required to obtain a business licence for a home-based business. Permits ensure the intentions and character of residential neighbourhoods are maintained. These regulations and conditions are contained within the Land Use Bylaw.

Is the development permit and business licence renewal a yearly requirement?

The development permit approval is only required once provided that the business does not intensify, the business does not stop operation for a period of 12 months, additional businesses are not added to the location or the business is not moved to a new location. The business licence is required to be renewed annually.

What if I move or discontinue operation?

All development permits are site specific and would become invalid after 12 months of no activity on the site.

New changes to the City's Land Use Bylaw surrounding home based businesses

- Major and Minor Home-Based Businesses must display a window card that is visible from the street
- Limited businesses have been added as a "type" of home-based business
- Listed prohibited home-based businesses
- Set maximum number of client visits per week
- Created additional enforcement regulations that extend to both Development Officers and Bylaw Officers

Major Development permit decisions are generally issued within4-8 weeks of receipt of a complete application due to provincially legislated requirements that cannot be altered.	A development allowing the secondary use of a residential dwelling for the purpose of a business by the full-time occupant of the dwelling, which includes business-associated visits to the residence, up to one additional non-resident employee, and limited use of a rear yard or accessory building. ¹ It is recommended that customers contact the planning department to discuss Home-Based Business Limited before trying to obtain a business licence to ensure that the home-based business does in fact fall within the regulations of not requiring Development Permit Approval.

² Should the minor application be within a direct control district, it could take 4 to 8 weeks for a decision as uses within these districts are required to go before council for a decision.

³ The development permit approval does not expire provided that the business doesn't intensify, the business doesn't stop operation for a period of 12 months, additional businesses aren't added to the location, the business isn't moved to a new location and/or the business licence is renewed annually and all conditions and regulations pertaining to home-based business as listed within Land Use Bylaw is adhered to.
