BYLAW NO. 28-2022

A BYLAW OF THE CITY OF LLOYDMINSTER IN THE PROVINCES OF ALBERTA AND SASKATCHEWAN TO PROVIDE FOR THE ESTABLISHMENT OF A LANDFILL USE BYLAW.

WHEREAS the Council of the City of Lloydminster deems it necessary to establish a Bylaw to deal with the safety, health, and welfare of people, the protection of people and property, services provided by or on behalf of the City, and public utilities;

AND WHEREAS the *Lloydminster Charter* provides authority to City Council to pass bylaws given by this Charter is to be interpreted as including the power to: establish fees for the activity authorized, including fees that may be in the nature of a reasonable tax or for the purpose of raising revenue; establish fees that are higher for persons who do not reside or maintain a place of business in the City or for businesses that are not located in the City compared with fees for persons or businesses in the City;

AND WHEREAS the *Lloydminster Charter* provides authority to the City to pass bylaws respecting the enforcement of bylaws;

NOW THEREFORE, the Council of the City of Lloydminster, pursuant to the authority granted in the *Lloydminster Charter*, enacts as follows:

1. SHORT TITLE

1.1. This Bylaw shall be cited as the "Landfill Use Bylaw".

2. **DEFINITIONS**

2.1. The definitions listed in Schedule "A" attached to this Bylaw shall apply, unless context otherwise requires.

3. APPOINTMENT, AUTHORITY AND DUTIES OF THE CITY MANAGER

- 3.1. Except where specific authority is reserved to Council in the Bylaw, the administration and enforcement of this Bylaw is hereby delegated to the City Manager.
- 3.2. Without restricting any other power, duty or function granted by this Bylaw, the City Manager may carry out anything required for the administration of this Bylaw, including but not limited to the following:
 - delegate any powers, duties or functions under this Bylaw to an employee of the City;
 - 3.2.2. carry out any inspections that are reasonably required to determine compliance with this Bylaw;
 - 3.2.3. establish any forms required for the administration of this Bylaw.

4. ACCEPTABLE AND PROHIBITED WASTE

4.1. A list of Acceptable Waste for landfill disposal is detailed in Schedule "B", Acceptable Waste, which is attached to and forms part of this Bylaw.

- 4.2. A list of Prohibited Waste is detailed in Schedule "C", Prohibited Waste, which is attached to and forms part of this Bylaw.
- 4.3. Any waste not identified as Acceptable Waste shall be subject to further investigation and approval by the City Manager prior to the load being allowed access or tipping at the City of Lloydminster Landfill.

5. LANDFILL MATERIALS BAN

- 5.1. The following recyclable materials shall be banned from the landfill's Working Face:
 - 5.1.1. Metal
 - 5.1.2. Clean Concrete
 - 5.1.3. Non-Coated Cardboard
- 5.2. Loads containing more than five percent (5%) (by visual inspection) of the said materials shall be charged "Mixed load" plus custom billing spent for sorting. Custom billing will be calculated from landfill Man-hours and equipment hours and current loaded rates.

6. DISPUTED LOADS

6.1. Notification and investigation of a disputed load:

In the event that a landfill customer does not agree with a landfill charge, the customer has the option to dispute the said load or ticket within fifteen (15) business days from the date the load was tipped at the landfill. The customer is required to submit notification of the dispute in writing supplying the load information and the reason(s) the landfill charge is being disputed. The City will investigate and notify the customer if adjustments to the bill will be made. If the disputed load was not brought to the City's attention within fifteen (15) business days, the customer will be required to pay the original invoiced amount.

6.2. Third Party Load:

In the event that the customer (hauler) was hauling for another company (generator), the City will not mediate between the hauler and the generator. The customer with the landfill account will be billed the corresponding amount and will be responsible for the landfill fee.

7. COMPLIANCE TO LANDFILL SITE REGULATIONS

- 7.1. Customers using the City of Lloydminster Landfill shall comply with the landfill site regulations, as posted at the landfill. Customers shall report to the Scalehouse, follow directions given, and deposit waste in the designated location, as instructed. Any person deemed not compliant can be refused access to the landfill at the discretion of the City Manager.
- 7.2. Any person behaving in an unsafe manner, using threatening or abusive gestures shall be denied access to the landfill at the discretion of the City Manager.

8. UNPAID LANDFILL FEES

- 8.1. Landfill fees are due upon receipt of the invoice and will be considered late if not paid within thirty (30) days of the invoice date. All unpaid fees will be subject to a finance charge of 1.5% per month.
- 8.2. Customers whose accounts have been cancelled due to unpaid landfill fees past ninety (90) days shall be eligible to re-apply for an account once full payment of outstanding balance including the finance charge has been processed. This account will remain under probation for a period of six (6) months. Customers whose accounts have been cancelled three (3) times for late payment will no longer be eligible to re-apply and will be required to pay at the landfill on a per use basis.

9. FEES AND SURCHARGES - EXPLANATION

9.1. Fees

9.1.1. All persons hauling waste that is assessed acceptable to the landfill shall pay disposal fees as directed in Schedule "D", Fees and Surcharges, which is attached to and forms part of this Bylaw.

9.2. Surcharge

9.2.1. Extended Hours Surcharge

Extended hours surcharge will be applied to a customer requesting the landfill to extend hours beyond normal posted operating hours. This surcharge defrays the additional cost to extend the operating hours of the landfill. Minimum charge for extended hours: one (1) hour.

9.2.2. Oversized Concrete Surcharge

Oversized concrete surcharge will be applied to concrete loads if more than twenty-five percent (25%) of the visible load does not meet the recycling size specification for Clean Concrete and Asphalt. Oversized concrete surcharge defrays the additional cost associated with recycling oversized concrete.

9.2.3. Unsecured Load Surcharge

Unsecured load surcharge is applied to any vehicle coming into the landfill with unsecured loads. Examples of acceptable practices of securing loads include but are not limited to: using a tarp, using nets, or using heavy materials to weigh down the load.

9.2.4. Weighing Fee

Weighing fee is applied to loads that are coming into the landfill for the sole purpose of being weighed; no material will be offloaded. This fee defrays the cost of operating the Scalehouse.



10. NUMBER AND GENDER REFERENCES

10.1. All references in this Bylaw will be read with such changes in number and gender as may be appropriate according to whether the reference is to a male or female person, or a corporation or partnership.

11. SEVERABILITY

11.1. Every provision of this Bylaw is independent of all other provisions and if any provision of this Bylaw is declared invalid for any reason by a court of competent jurisdiction, all other provisions of this Bylaw shall remain valid and enforceable.

This Bylaw shall come into force and effect on the 1st day of January 2023.

SCHEDULE "B"

Acceptable Waste

City of Lloydminster Landfill shall accept non-hazardous waste for landfill disposal, treatment, or recycling. Acceptable waste includes but is not limited to:

1. Landfilled

- a. Garbage
- b. Unrecyclable Concrete
- c. Construction/Demolition Waste
- d. Specified Risk Material
- e. Asbestos
- f. Mattress

2. Treated

(Requires approval as per the Sump Waste Acceptance, Handling and Disposal Procedure)

- a. Septic Waste
- b. Sump and Hydrovac Waste

3. Recycled

- a. Used Oil, Filters, Containers and Glycol
- b. Cardboard and Blue Bag Material
- c. Electronics
- d. Battery
- e. Paint
- f. Tires
- g. Metal and Appliance
- h. Clean Fill
- i. Clean concrete and Asphalt
- j. Wood

Disposal of these materials are subject to fees and surcharges as per Schedule "D" of this Bylaw.



Schedule "C"

Prohibited Waste

All substances listed in the Saskatchewan Hazardous Substances and Waste Dangerous Goods Regulations as explosives, gases, flammable liquids, flammable solids, oxidizing substances, organic peroxides, poisonous substances, infectious substances, radioactive material, corrosive substances, including their containers are prohibited from the landfill.

Prohibited waste includes but is not limited to:

- a. PCB's Polychlorinated Biphenyls
- b. Automobile bodies
- c. Infectious/biomedical waste
- d. Dry cleaning fluids
- e. Coated/wrapped metal pipe/yellow jacket
- f. Paint thinner/varsol
- g. Bulk liquid, except Sump, Hydro vac and Septic Waste materials
- h. Electroplating products
- i. Unwashed plastic or metal chemical containers
- j. Fuel tanks including automotive and storage unless steamed and cut in manageable size
- k. Petroleum remains or by-products (except soil to be recycled)
- I. Concrete with rebar protruding more than six (6) inches
- m. Bulk quantity concrete powder or any powder substance; unless proven to be a non-hazardous/dangerous substance
- n. Pipe or tubing of any type unless it is cut into four (4) foot lengths
- o. Oilfield waste: Any unwanted substance (by the generator) or mixture of substances that results from the construction, operation or reclamation of a well site, oil and gas battery, gas plant, compressor station, crude oil terminal, pipeline, gas gathering system, heavy oil site, oil sands site, or related facility
- p. Bentonite
- q. Ammunition Casings
- r. Chemicals of any kind
- s. Herbicide/pesticide containers
- t. Concrete filled pipe
- u. Agriculture pesticide and containers
- v. Spoiled grain
- w. Explosives, combustibles, compressed gas containers
- x. Any material not listed as permitted is prohibited pending prior arrangement with the Landfill Foreman. Landfill staff will refuse the disposal of any unknown substance that is deemed to be potentially hazardous to the environment.
